<b>Low Risk –</b>	<b>Medium Risk –</b>	<b>High Risk –</b>
Something which may result in minor damage or slight harm (i.e. scratch or bruise)	Something which may result in a significant loss/damage or major injury (broken bone or other injury, which results in person being taken to hospital for treatment)	Something which may result in extensive damage, multiple major injuries or death

Ensure tools are sharp and in good condition.</li> <li>• Trained CWA first aider c/w first aid kit to be on location</li> </ul>	Low	All CWA volunteers
Fire / Stove	Severe burns to individual	High	<ul style="list-style-type: none"> <li>• Group supervision, positioning and awareness. Define boundaries.</li> <li>• Trained CWA first aider c/w first aid kit to be on location</li> <li>• Refer to environmental hazards risk assessment</li> </ul>	Low	All CWA volunteers
Rough Terrain	Potential to sprain or broken limbs.	Medium	<ul style="list-style-type: none"> <li>• Define clear boundaries.</li> <li>• Trained CWA first aider c/w first aid kit to be on location</li> <li>• Refer to the woodlands management risk assessment.</li> </ul>	Low	All CWA volunteers
Pole Lathe	Laceration to limbs / hands	Medium	<ul style="list-style-type: none"> <li>• Positioning of group.</li> <li>• Clear briefing and close supervision</li> <li>• Trained CWA first aider c/w first aid kit to be on location</li> </ul>	Low	All CWA volunteers

Use of chemical toilet	Risk of infection to personnel	Medium	<ul style="list-style-type: none"><li>• Ensure toilet facilities are kept in a clean state.</li><li>• Maintain a toilet inspection register to ensure standards are maintained.</li><li>• Perform regular inspections of toilet facilities.</li><li>• Ensure all CWA personnel and visitors that may use the toilet facilities are made aware of all potential risks associated with cleanliness.</li><li>• Sanitising Gel / Hand wipes to be available.</li><li>• Ensure no open wounds.</li><li>• Refer to woodlands management risk assessment.</li></ul>	Low	CWA Committee
